Sir/ Madam,

With reference to the subject as noted above, I am directed to say that the State Election Commission used to hold Local Body Election viz. PRIs, Municipal Boards, GMC, 6th Schedule Councils and also a no. of Tribal Autonomous Councils. The State Election Commission proposes an exercise of financial planning for conduct of the aforesaid Elections to be held from time to time taking into consideration of pattern of expenditure in the last Assembly Election(2016).

You are, therefore, requested to furnish the following information as regards such expenditure, to take as reference by the State Election Commission.

- 1) Total expenditure including committed liability(if any) in holding the Election in respect of the District/ Sub-Division, indicating item wise expenditure.
- 2) Total no. of Assembly Constituencies and Polling Stations.

DCs and SDO(C)s will please furnish information on expenditure of Constituencies where they have been notified as DEO. Concerned SPs will please furnish the information on expenditure of his entire district. If it is not possible to provide Constituency wise expenditure, total expenditure for the District/Sub-Division (DEO wise) may please be furnished.

The matter may be taken as urgent.
