NOTIFICATION

The 11th May, 2017

No. SEC.53/2016/Pt/36.- Whereas the Governor of Assam is pleased to entrust the Assam State Election Commission vide Notification No.HAD.305/2011 dated 5th December, 2011, the power to conduct the Election to Karbi Anglong Autonomous Council as per provision of Assam Autonomous Districts (Constitution of District Councils) Rules, 1951;

And, whereas subject to control and superintendence of the Assam State Election Commission, the respective Returning Officers Viz. Deputy Commissioner, Karbi Anglong, Diphu; Deputy Commissioner, West Karbi Anglong, Hamren and Sub-Divisional Officer(C), Bokajan have already prepared and published the Final Electoral Rolls of the respective Constituencies of the Karbi Anglong Autonomous Council, as per relevant provision of Assam Autonomous Districts (Constitution of District Councils) Rules, 1951 (as amended upto date);

And, whereas the Assam State Election Commission has duly taken notice of the Govt. Notification vide No.HAD.265/2011/79 dated 9th January, 2017, extending the term of the present Council by a period of six months with effect from 13th January, 2017 or till the date of 1st sitting after completion of the fresh poll to the Karbi Anglong Autonomous Council to be conducted by the Assam State Election Commission, whichever is earlier;

And, whereas the Assam State Election Commission has also duly taken notice of the Judgment & order of the Hon'ble Gauhati High Court dated 01.03.2017 in PIL No.03/2017 regarding holding the Election to the Karbi Anglong Autonomous Council within the extended term of the Karbi Anglong Autonomous Council;

Now, therefore, in pursuance of the provision of Rule 124(2) and Rule 133 (2) of Assam Autonomous Districts (Constitution of District Councils) Rules, 1951, the Assam State Election Commission calls upon the Karbi Anglong Autonomous Council Constituencies mentioned below to elect Members to re-constitute Karbi Anglong Autonomous Council as per schedule given below:
