No.SEC.44/2014/pt/170 : Whereas, in exercise of powers conferred under the provision of the Rule 4 of the Deori Autonomous Council (Election) Rules, 2009 and in pursuance of the Govt. (in WPT & BC Deptt.) communication vide No. TAD/BC/157/2015/3 dated 18.04.2015 the Assam State Election Commission appointed DEO/RO/ARO in respect of 18(eighteen) nos. of Constituencies of the Deori Autonomous Council for conduct of Election vide Notification No. SEC.44/2015/Pt/140 dated 06-06-2016; SEC 44/2014/Pt/142 dtd. 07.06.2016 and SEC 44/2014/Pt/145 dtd. 15.06.2016

And, whereas, the Assam State Election Commission notified Schedule for preparation and publication of constituency wise Electoral Roll for Election to the Deori Autonomous Council vide Notification No. SEC.44/2014/Pt/161 dated 14-09-2016;

And, Whereas, the final Electoral Rolls in 18 (eighteen) Constituencies under districts of Jorhat, Sivasagar, Charaideo, Dibrugarh, Tinsukia, Dhemaji, Biswanath Chariali and Lakhimpur have been published;

And, whereas, reservation of seats for women in the Deori Autonomous Council has been notified vide No. TAD/BC/467/2015/31 dated 03-06-2016;

Now, therefore, in pursuance of Rule 17(I) and Rule 18 of the Deori Autonomous Council (Election) Rules 2009, the Assam State Election Commission do hereby notify to call upon each of 18 (eighteen)nos. of Deori Autonomous Council Constituencies as specified at Para A below to elect members to the Deori Autonomous Council in the state of Assam in accordance with the provisions of the said Act and Rules and orders made thereunder.

Further, the Commission hereby declares the notification for Second Election to Deori Autonomous Council, 2016 as per schedule at Para B, below, for holding of Election of Member to Deori Autonomous Council from each of the 18(eighteen) nos. of Deori Autonomous Council Constituencies as above mentioned.

The Returning Officers already appointed to conduct the Election shall forthwith publish Public Notice of Election as per Rule 19 of the Deori Autonomous Council (Election) Rules, 2009, (on the same day of this Notification).
