No. SEC.42/2022/ 3 : Whereas, the Governor of Assam was pleased to entrust the Assam State Election Commission with the mandate of superintendence, direction and control of the preparation of electoral rolls for, and conduct of elections to the Karbi Anglong Autonomous District Council vide Notifications No. HAD.305/2011 dated 05.12.2011 and No. HAD.305/2011/30 dated 02.11.2021 ;

And, whereas subject to the control and superintendence of the Assam State Election Commission, the respective Returning Officers viz.
