Qualifying date for preparation of the Electoral Roll is **01.03.2016**.

Returning Officers may engage the Authorised Officer already notified vide Commission's notification dated 26.10.2016 to assist the Returning Officer in preparation of the Electoral Rolls. If the Returning Officer considers necessary, a second official not below Gazetted status may also be engaged for preparation of the Electoral Rolls, however, only with prior approval of the State Election Commission.

The Returning Officers are also authorised to engage additional staff to assist the Returning Officer and Authorised Officer (to function as Returning Officer) in preparation of the Electoral Rolls.
