It is stated that the State Election Commission is responsible for holding Election/Bye-Election to the vacant offices of President, Gaon Panchayat and Members of Gaon Panchayat, Anchalik Panchayat and Zila Parishad as per provision of Panchayat Act and Rules. As regards matters/issues such as filling up of vacancies of Vice President, Gaon Panchayat, President/Vice President of Anchalik Panchayat and Zila Parishad, you are requested to take action as per relevant provision of the relevant Panchayat Act and Rules with intimation only to the Commission. In such matters, the Commission is not required to offer any instruction/ suggestion. The Commission, however, be informed of the names and addresses of the new incumbent(s) elected/selected by the Panchayat bodies after exit of the previous incumbents for one or another reason for records.
