Sir,

With reference to the above, I am directed to say that the State Election Commission has slightly modified the format of Nomination Paper both English and Assamese (Appendix-6) and also format of Return of Election Expenses etc.(Appendix 12) and modified copies of the same have been enclosed as Annexure 1 & 2.

- 2. Secondly, the candidates or any other person on behalf of the candidates collecting nomination form after issue of the Election notification shall be provided with copies of the followings along with the nomination form.
 - 1) Form of Affidavit A and 2) Affidavit B along with 3) statement on assets and liabilities and 4) statement of criminal cases and conviction etc. The Affidavits will be attested by the Returning Officer or the Authorised Officer as the case may be, receiving nomination from candidates. Copies of Affidavit A and Affidavit B along with the statements are enclosed as Annexure 3 & 4.
- 3. For any other requirement of nomination, Returning Officer/ Authorised Officer shall comply with the provisions under the relevant Rules. The Returning Officers/ District Election Officers should ensure that all the Authorised Officers are adequately apprised of the relevant provisions of the Rules regarding nomination, scrutiny, withdrawal etc. and also regarding conduct of Election and counting. The District Election Officers may organise Interactive Session with the Authorised Officers on rules and procedure of Election for the purpose of smooth conduct of the Election even before the Election Notification is issued by the State Election Commission. The State Election Commission may also be informed about plan of such Interactive Session indicating the venue and dates etc.
- 4. The District Election Officers also will please visit Commission's website www.secassam.in regularly everyday and also advise the Authorised Officers accordingly. In case of any confusion or inconsistency observed by Returning Officer regarding provision of the Rules may be brought immediately to the notice of the State Election Commission.
