Last date for submission of quotation is 2:00 PM of 21st August, 2018. The tenders will be opened on the same day (21st August, 2018 at 3:00 PM and interested firms/ parties or their representatives may remain present.

Terms & Conditions

- 1) The price quoted shall be valid for a period of 1(one) year from the last date fixed for the receipt of Tender/quotation.
- 2) The supply should be made within 7 (seven) days from the date of receipt of the order.
- 3) The rate should be quoted inclusive of all taxes and other charges as applicable.
- 4) The undersigned reserves the right to reject any or all the tenders /quotation without assigning any reasons thereto and without incurring any liabilities/ obligations on the part of the Assam State Election Commission.
- 5) Authority reserves the right to check the quality of the supplied items.
- 6) Minimum 3 (three) years onsite warranty for the items will have to be provided free of cost by the supplier at site.
- 7) Firms will have to submit copies of : Firm Registration, GST Registration Certificate, Valid & up-to-date Trade Licenses, Pan Card etc. along with the tender.
- 8) Bidders will have to deposit Earnest money @ Rs. 2% of the total bid value in the form of Bank draft in favour of "Secretary, Assam State Election Commission" payable at SBI, Dispur Branch.
