Whereas, the Assam State Election Commission has duly taken note of the orders of the Hon'ble Gauhati High Court for holding bye-election etc. to casual vacancies in respect of viz. (1) dated 05.08.2016 in WP(C) NO. 4581/2016 in respect of President, No. 4 Algapur Gaon Panchayat; (2) dated 15.07.2016 in WP(C) No. 4033/2016 in respect of President, No. 3 Harishnagar Gaon Panchayat; (3) dated 02.09.2016 in WP(C) No. 5164/2016 in respect of President, No. 49 Mazigram Gaon Panchayat; (4) dated 20.07.2016 in WP(C) No. 4145/2016 in respect of President, 66 No. Dingdinga Gaon Panchayat; (5) dated 20.06.2016 in WP(C) No. 3596/2016 in respect of President, No. 33 Nagabandha Gaon Panchayat; (6) dated 23.09.2016 in WP(C) No. 5704/2016 in respect of President, No. 10 Dakhin Saidpur Gaon Panchayat;

And, whereas, pursuant to direction from the Assam State Election Commission the concerned Deputy Commissioners have already published Electoral Rolls for above mentioned constituencies in fulfilment of the provisions laid down under Rule 12 of the Assam Panchayat (Constitution) Rules, 1995;

And, whereas, Assam State Election Commission has notified the Final Electoral Roll in respect of the said constituencies vide Notification No. SEC. 03/2017/34 dated 21.02.2017;

Now, therefore, in exercise of powers conferred under Article 243(K) of the Constitution of India and Section 114 of the Assam Panchayat Act, 1994 (as amended) and Rule 15 and Rule 16 of the Assam Panchayat (Constitution) Rules, 1995, and in compliance of the order of the Hon'ble High Court as above noted, the Assam State Election Commission on this 21st day of February, 2017, hereby, notifies the schedule for bye-election to the vacancies of (1) President, No. 4 Algapur Gaon Panchayat in Hailakandi District; (2) President, No. 3 Harishnagar Gaon Panchayat in Hailakandi District; (3) President, No. 49 Mazigram Gaon Panchayat in Karimganj District; (4) President, 66 No. Dingdinga Parowa Gaon Panchayat in Dhubri District; (5) President, No. 33 Nagabandha Gaon Panchayat in Morigaon District; (6) President, No.10 Dakhin Saidpur Gaon Panchayat in Cachar District as follows;



| 6. Date of Poll | 22.03.2017 (From 08:00 AM - 04:00 PM) |
| 7. Date of Re-poll (if any) | 23.03.2017 (From 08:00 AM - 04:00 PM) |
| 8. Counting of votes | 24.03.2017 (From 08:00 AM till counting is completed) |

The concerned Deputy Commissioner shall appoint one Authorised Officer with prior approval of the Assam State Election Commission to receive, scrutinise etc. of the nomination papers and conduct of election on the date, time and place notified for the purpose under provision of Rule 22 of the Assam Panchayat (Constitution) Rules, 1995.

The Deputy Commissioners shall publish a notice on the same day of this notification by the Commission under provision of Rule 16 (1) of the Assam Panchayat (Constitution) Rules, 1995.

With this notification the Model Code of Conduct for Election comes into force in the areas covered by the above mentioned six Panchayati Raj Constituencies.

Further appropriate reservation status as regards ST, SC and Women of the concerned constituencies shall be indicated as per records available with Deputy Commissioner, in the notice to be published under aforesaid Rule 16 (1).
