Exemption from withdrawal limit of fund from bank to facilitate the conduct of Election to Deori Autonomous Council and Thengal Kachari Autonomous Council.

Sir,

With reference to the subject as noted above, I am directed to say that the Assam State Election Commission is a constitutional authority notified under Article 243K and 243ZA of the Constitution of India to conduct Elections to local bodies viz. Panchayat Bodies and Municipal Bodies. However, the State Govt. of Assam has entrusted the Assam State Election Commission to conduct Elections to the Deori Autonomous Council and Thengal Kachari Autonomous Council vide No. TAD/BC/157/2015/3 dt. 18.04.2015 (Copies of State Govt. notification dt. 18.04.2016 enclosed herewith as Annexure- 1). It is to be mentioned that both the Deori Autonomous Council and Thengal Kachari Autonomous Council have been constituted under the Deori Autonomous Council Act (an Act of Assam) and Thengal Kachari Autonomous Council Act (an Act of Assam) respectively and its Elections are conducted under relevant Rules of the respective council. The State Election Commission has already notified schedule of the Election to the aforesaid Councils vide notification No. SEC. 44/2014/Pt/173 dt. 24.10. 2016 in respect of Deori Autonomous Council and notification No. SEC. 45/2014/189 dt. 24.10.2016 in respect of Thengal Kachari Autonomous Council. As per the said Election Schedule the Poll will be held on 15.12.2016 and the State Election Commission as well as field officials viz. concerned DCs, SPs and SDO(C)s have been fully prepared to conduct the Election. The State Govt. has also in the meantime sanctioned and released fund to the State Election Commission for conducting the said Elections vide No. TAD/BC/392/2015/174 dt. 19.10.2016 in respect of Deori Autonomous Council and vide No. TAD/BC/392/2015/173 dt. 19.10.2016 (Copies of the letters enclosed as Annexure 2 & 3). Now that considering the nature of payment related to election expenses cash fund is necessary substantially for the officials viz. RO (DC/SDO(C)) and SP as well as to the State Election Commission.

Under the circumstances as narrated above, I would like to request you to issue necessary exemption in withdrawal limit of cash beyond the stipulated limit of Rs. 24000.00 to the above mentioned authorities involved in conduct of the aforesaid Elections.
