**NOTIFICATION**

Dated Dispur the 24<sup>th</sup> October, 2016

No.SEC.44/2014/pt/173 : Whereas, the next Election to the Deori Autonomous Council has been notified by Assam State Election Commission vide notification No.SEC.44/2014/pt/170, dt. 21.10.2016, wherein the Election schedule has been notified as: Last date of filing nominations- 28.10.2016, Scrutiny of nomination papers- 31.10.2016, List of validly nominated candidates - 31.10.2016, Withdrawal of candidature- 02.11.2016, Publication of list of contesting candidates- 02.11.2016, Date of Poll - 16.11.2016, Date of Re-Poll (if any)- 17.11.2016 and Date of Counting - 21.11.2016;

Whereas, Election schedule of the Thengal Kachari Autonomous Council has also been notified vide No.SEC.45/2014/180, dt. 21.10.2016 with Election Schedule being the same as that of the Election to the Deori Autonomous Council;

Whereas, the Election Commission of India has also notified Bye-Election to the 14-Lakhimpur PC in respect of which the Election schedule has been as follows; Last Date of Nomination - 02.11.2016; Date for scrutiny of nomination - 03.11.2016; Last date of withdrawal of candidatures - 05.11.2016; Date of Poll - 19.11.2016; Date of Counting - 22.11.2016;

Whereas, in view of the Election schedules as above, in districts like Lakhimpur and Dhemaji, all the aforesaid 3 (three) Election will have to be conducted during almost the same period;

Whereas, some Organizations have represented for postponement/deferment of Election to the Deori Autonomous Council and Thengal Kachari Autonomous Council on the grounds of ongoing process of Bye-Election to 14-Lakhimpur PC and also some District Election Officers have communicated about practical difficulties in holding all the 3 (three) Elections at a time;

And, whereas the State Election Commission considering the facts, grounds and circumstances as above is of the view that conducting all the 3 (Three) Election almost at a time in a few Districts viz. Lakhimpur and Dhemaji, is likely to hamper conduct of free, fair and hasslefree Election to the Deori Autonomous Council;

The State Election Commission, therefore, in the interest of free, fair and smooth conduct of Election to the Deori Autonomous Council suspends the schedule of the Election to the Deori Autonomous Council notified vide No. SEC. 44/2014/P/170, dt. 21.10.2016 w.e.f. 3:00 PM of 24.10.2016 to recommence on 23.11.2016 as per revised schedule given below.
