UNDER RULE 326 (a) OF ASSAM EXCISE RULES 2016 AND UNDER RULE 52 OF THE ASSAM EXCISE ACT 2000 IN RESPECT OF HOLDING THE **1ST PHASE OF GENRAL ELECTION TO THE PANCHAYATS** OF THE STATE OF ASSAM COMMA THE GOVERNOR OF ASSAM HEREBY PROHIBITS THE POSSESSION OF ANY INTOXICANTS BY ANY PERSON OR GROUP OF PERSONS AND BAN ON SALE OF LIQUOR COMMA GIVING OR DISTRIBUTION OF SPIRITUOUS COMMA FERMENTED OR INTOXICATING LIQUORS OR OTHER SUBSTANCES OF ALIKE NATURE AT A HOTEL COMMA PUBLIC EATING HOUSE COMMA TAVERN COMMA SHOP OR ANY OTHER PLACE COMMA PUBLIC OR PRIVATE WITHIN THE POLLING AREA **DURING THE PERIOD OF 48 (FORTY EIGHT) HOURS ENDING WITH THE HOURS FIXED FOR THE CONCLUSION OF POLL (3:00 P.M OF 05.12.2018) THAT IS FROM 3:00 P.M. OF 03.12.2018 TO 3:00 PM TO 05.12.2018 IN CONNECTION WITH THE ENSUING GENERAL ELECTION TO THE PANCHAYATS OF THE STATE SCHEDULED TO BE HELD ON 05.12.2018 IS DECLARED AS DRY DAYS INCLUDING THE DAY OF COUNTING OF VOTES WHICH IS FIXED ON 12.12.2018 IS ALSO DECLARED AS DRY DAY TILL THE PROCESS OF COUNTING IS OVER** (.) ALL BONDED WAREHOUSE COMMA IMFL RETAIL 'OFF' AND 'ON' SHOPS INCLUDING CLUB 'ON' COMMA HOTEL 'ON' AND COUNTRY SPIRIT SHOPS WILL REMAIN CLOSED DURING THE DRY DAYS (.) FURTHER COMMA DURING THIS PERIOD THE STORAGE OF LIQUOR BY INDIVIDUALS SHALL BE CURTAILED (.) DURING THE ABOVE PERIOD THE RESTRICTIONS PROVIDED IN THE EXCISE LAW ON THE STORAGE OF LIQUOR IN UNLICENSED PREMISES SHALL BE VIGOROUSLY ENFORCED (.) STEPS SHALL ALSO BE TAKEN TO PROHIBIT SALE OF LIQUOR IN ADJOINING AREAS OF THE CONCERNED POLLING STATION AREAS SO THAT THERE ARE NO CHANCES OF CLANDESTINE MOVEMENT OF LIQUOR FROM THOSE AREAS WHERE THE RESTRICTION HAS NOT BEEN IN OPERATION (.)
