

IT WAS INDICATED IN THE SAID LETTER THAT THE INTENTION OF THIS UPDATION WAS TO INCLUDE NAMES OF SUCH VOTERS WHOSE NAMES EXIST IN THE ELECTORAL ROLL OF ASSEMBLY ELECTION 2016 BUT LEFT OUT IN THE DRAFT ELECTORAL ROLLS OF DAC AND TKAC(.) IT AUTOMATICALLY IMPLIES THAT QUALIFYING DATE FOR THE UP-TO-DATE ELECTORAL ROLLS IS 1ST JANUARY 2016 AS THE ASSEMBLY ELECTORAL ROLLS, 2016 HAS BEEN PREPARED AS QUALIFYING DATE OF 1ST JANUARY 2016(.) IN CASE ANY DEPCOM AND SUB-DIVISIONAL HAS PREPARED THE ELECTORAL ROLLS WITH QUALIFYING DATE OTHER THAN 01.01.2016 SUCH ELECTORAL ROLLS ARE TO BE PREPARED CORRECTLY WITH QUALIFYING DATE OF 01.01.2016. FOR SUCH CASES THE LAST DATE FOR PUBLICATION OF THE FINAL ELECTORAL ROLLS IS EXTENDED UPTO 20.10.2016(.) MATTER MOST URGENT.(.)
