Dated Dispur, the 5th September, 2017.**Order**

Pursuant to proposal received from DC, Dhubri vide No. DDP-10/2017/ dated 22.08.2017 and based on feedback got in the meeting held on 31.08.2017 in the office of DC, Dhubri attended by both DCs and SPs of districts of Dhubri and South Salmara and other Senior officials of the district connected to conduct of Panchayat Election, the Assam State Election Commission in exercise of its authority under Article 243 K of the Constitution of India decides as regards area of Election district of the Dhubri and South Salmara Districts as follows, in the interest of smooth and hassle free election.

- 1) DC, Dhubri will conduct Panchayat Election to below mentioned 13 number of Zilla Parishad Constituencies viz. (1) 10- Gaspara, (2) 11- Motirchar, (3) 12- Adbari, (4) 13- Madhusoulmari-Tiamari, (5) 14- Uttar Geramari, (6) 15- Alomganj, (7) 16- Madhusoulmari, (8) 17- Moterjhar, (9) 18- Golokganj, (10) 19- Kumarganj, (11) 20- Halakura, (12) 21- Agomani and (13) 22- Hatidhura within district of Dhubri. The Election district of Dhubri for ensuing Panchayat Election will consist the area under the said 13 number of Zilla Parishad Constituencies.
- 2) DC, South Salmara will conduct Election for a total of 9 (nine) Zilla Parishad Constituencies viz. (1) 1- Kakripara, (2) 2- Kalapani, (3) 3- Fekamari, (4) 4- Sukchar, (5) 5- Dakkhin Salmara, (6) 6- Fakirganj, (7) 7- Chalakura, (8) 8- Bahir Salmara and (9) 9- Airkata, the first 5 (five) ZPCs being situated within the present (newly created) district of South Salmara and the remaining 4 (four) ZPCs being administratively in the newly created district of Dhubri. The Panchayat Election District of South Salmara shall consist of aforesaid 9 (nine) ZPC.

This above arrangement has been made considering the factors like 1) Communication convenience, 2) police (SP) jurisdiction; 3) earlier experience of conduct of such Election by the respective DEOs.


