And, whereas, the State Election Commission has duly taken note of the orders of the Hon'ble Gauhati High Court related directly or indirectly to holding bye-election etc. viz. And, whereas, pursuant to direction from the Assam State Election Commission the respective Deputy Commissioner/Sub-Divisional Officer(C) have published Electoral Rolls for above mentioned constituencies in fulfilment of the provisions laid down under Rule 12 of the Assam Panchayat (Constitution) Rules, 1995;
