PLEASE REFER TO DISCUSSION HELD IN THE REVIEW MEETING HELD AT HAMREN ON 19/04/2017 REGARDING PRINTING OF BALLOT PAPERS CENTRALLY AT GUWAHATI (.) THE MATTER WAS TAKEN UP WITH THE DIRECTOR ASSAM GOVT PRINTING PRESS WHO HAS AGREED TO TAKE UP PRINTING OF BALLOT PAPERS ACCORDINGLY (.) IT HAS BEEN DECIDED ACCORDINGLY THAT THE BALLOT PAPERS OF ALL THE 26 CONSTITUENCIES WILL BE PRINTED AT THE ASSAM GOVT PRINTING PRESS AT GOVT APPROVED RATES (.) THE EXPENDITURE IN CONNECTION WITH SUCH PRINTING WILL HAVE TO BORN BY THE RESPECTIVE RETURNING OFFICER OUT OF FUND PLACED AT THEIR DISPOSAL AGAINST BILLS AUTHENTICATED BY THE DIRECTOR (COMMA) GOVT PRINTING PRESS (.) CONCERNED ROS WILL ENTRUST RESPONSIBLE AND RELIABLE OFFICIALS FOR THE TASK OF PRINTING OF BALLOT PAPERS WHO WILL HAVE TO BRING THE MANUSCRIPT OF BALLOT PAPERS OF THE RESPECTIVE CONSTITUENCIES BY MORNING OF 23RD MAY 2017 TO REACH THE ASSAM GOVT PRINTING PRESS (.) SUCH OFFICIALS WILL STAY BACK AT GUWAHATI (COMMA) UNDERTAKE PROOF READING OF THE BALLOT PAPERS ETC. AND RETURN ONLY WITH THE PRINTED BALLOT PAPERS (.)MESSAGE ENDS (.)
