No.SEC.45/2014/180 : Whereas, in exercise of powers conferred under the provision of the Rule 4 of the Thengal Kachari Autonomous Council (Election) Rules, 2010 and in pursuance of the Govt. (in WPT & BC Deptt.) communication vide No. TAD/BC/157/2015/3 dated 18-04-2015 the Assam State Election Commission appointed DEO/RO/ARO in respect of 22(twenty two) nos. of Constituencies of the Thengal Kachari Autonomous Council for conduct of Election vide Notification No. SEC.45/2015/134 dated 06.06.2016;

And, whereas, the Assam State Election Commission notified Schedule for preparation and publication of constituency wise Electoral Roll for Election to the Thengal Kachari Autonomous Council vide Notification No. SEC.45/2014/161 dated 14.09.2016;

And, Whereas, the final Electoral Rolls in 22(twenty two) Constituencies under Districts of Jorhat, Dibrugarh, Golaghat, Dhemaji and Lakhimpur have been published;

And, whereas, reservation of seats for women in the Thengal Kachari Autonomous Council has been notified vide No. TAD/BC/468/2015/30 dated 03.06.2016;

Now, therefore, in pursuance of Rule 17(I) and Rule 18 of the Thengal Kachari Autonomous Council (Election) Rules 2010, the Assam State Election Commission do hereby notify to call upon each of 22(twenty two) nos. of Thengal Kachari Autonomous Council constituencies as specified at Para A below to elect members to the Thengal Kachari Autonomous Council in the state of Assam in accordance with the provisions of the said Act and Rules and orders made thereunder.

Further, the Commission hereby declares the notification for Second Election to Thengal Kachari Autonomous Council, 2016 as per schedule at Para B, below, for holding Election of Member to Thengal Kachari Autonomous Council from each of the 22 (twenty two) nos. of Thengal Kachari Autonomous Council Constituencies as above mentioned.

The Returning Officers already appointed to conduct the Election shall forthwith publish Public Notice of Election as per Rule 19 of the Thengal Kachari Autonomous Council (Election) Rules, 2010, (on the same day of this Notification).
